Ka Agatha ka la ban jur ba dei ban don ia ki Child Safety Committee ha baroh ki skul, katkum ki kyndon ain kiba la don lypa. Ka la pynpaw ba ka ladep thoh sha ka tnad Pule Puthi ban pynmih ia ka jingpynbna halor kane.

Ka la ai khublei ia ki katto katne ki jingthmu kum ka Child Protection Policy jong ka Catholic Bishops’ Conference of India (CBCI), bad ka la kyntu ia kiwei pat ki jaka pule ban shim ia ki polisi kiba kum kine. Ha ka kyrdan jong ka imlang sahlang, ka Agatha ka la kdew ia ka Integrated Child Protection Scheme (ICPS), kaba la thaw ruh ia ki Child Protection Committee ha ka kyrdan jong ki shnong, block, bad distrik. Hynrei ka la kdew ba bun na kine ki komiti ki long ki bym treikam satia.
